

**@HSDHealth Message Three Individuals Test Positive:
1 HMHS male, 1 Central male, 1 Tatem male**

HSD Cases #35, #36, #37

11/19/2020

Dear Parents, Guardians, and Staff:

This letter is to inform you that (3) individuals in the Haddonfield School District tested positive for Coronavirus Disease 2019 (COVID-19).

Contact tracers will be using timelines based on the onset of symptoms and dates of positive test results. If there are individuals identified as close-contacts, whether the contacts happened in school or elsewhere, they will be notified by the district and/or the Camden County Department of Health, most likely within the next 24-48 hours.

Here are all of the details that we are permitted to share at this time:

Case #35: HMHS

- **The individual is a male in his 10s in Cohort B.**
- **The individual is asymptomatic.**
- **The individual was tested on Friday, November 13, and received a positive result on Tuesday, November 17. According to guidelines, there is a “look back” period beginning two days prior to either the administration of a positive test if asymptomatic or two days prior to symptoms with a positive test. In this case, the “look back” is Wednesday, November 11.**
- **This individual was last in school on Friday, October 30.**
- **Based on currently available information, this individual did not likely contract the virus in school.**

Case #36: Central

- **The individual is a juvenile male (under 10) in Cohort A.**
- **The individual is asymptomatic.**
- **The individual was tested on Wednesday, November 17, and received a positive result on Thursday, November 19. According to guidelines, there is a “look back” period beginning two days prior to either the administration of a positive test if asymptomatic or two days prior to symptoms with a positive test. In this case, the “look back” is Sunday, November 15.**
- **This individual was last in school on Tuesday, November 10.**
- **Based on currently available information, this individual did not likely contract the virus in school.**

Case #37: Tatem

- **The individual is a juvenile male (under 10) in Cohort A**
- **The individual is was symptomatic beginning on Monday, November 16.**
- **The individual was tested on Tuesday, November 17, and received a positive result on Thursday, November 19. According to guidelines, there is a “look back” period beginning two days prior to either the administration of a positive test if asymptomatic or two days prior to symptoms with a positive test. In this case, the “look back” is Friday, November 13.**
- **This individual was last in school on Tuesday, November 10.**

- Based on currently available information, this individual did not likely contract the virus in school.

The District is coordinating closely with public health officials and following CDC, state, and local health department guidelines in order to assure the health and safety of our community.

Cleaning and disinfecting of all exposed areas are completed daily. The school is also taking extra precautions to prevent the introduction and spread of viruses and other germs and is cleaning frequently touched surfaces daily.

The status of this situation is fluid, and we are monitoring it closely.

We understand the level of concern regarding COVID-19. We encourage parents and students to continue following the Centers for Disease Control & Prevention promoted safeguards, such as:

- Staying home when you are sick;
- Washing hands often with soap for at least 20 seconds;
- Covering coughs and sneezes and properly disposing of tissues;
- Limiting close contact with people who are sick and not sharing food, drinks, and utensils;
- Practicing social distancing;
- Wearing a face covering while in school, ([additional mask guidance](#));
- Continuing to monitor your health for symptoms.

As always, we appreciate our community's support and cooperation. We have shared all of the information that we are permitted to share publicly at this time. If there is additional information to share, we will do so under the guidance of our medical team and the Camden County Department of Health. You can assist us by remaining vigilant but sensible in your approach to dealing with this health concern. Below are some resources that might be helpful.
