

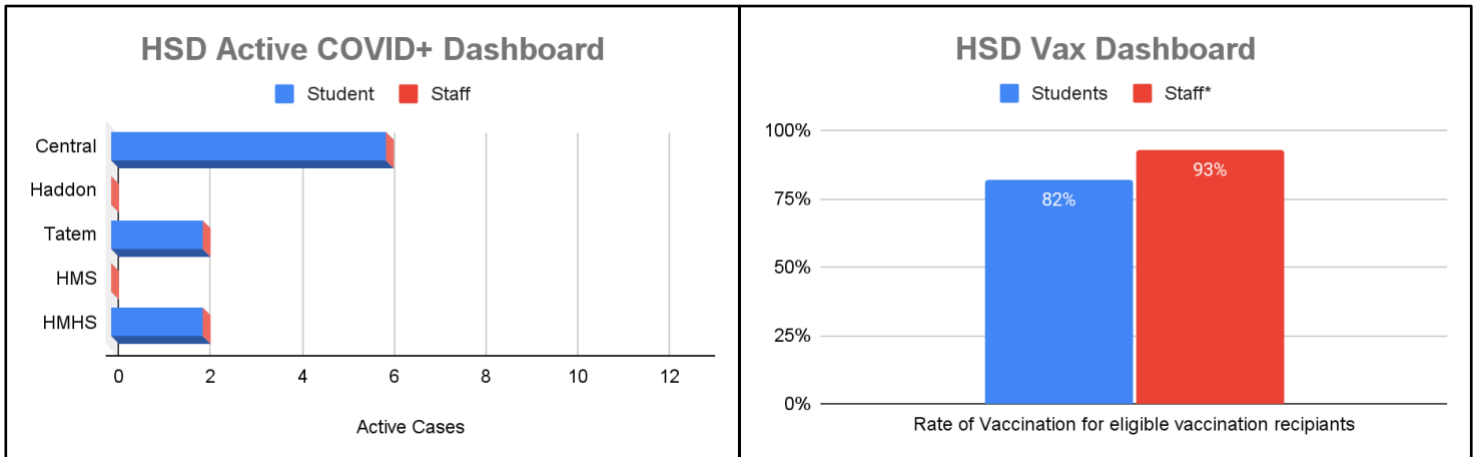

HSD Cases #58-#62



Dear Parents, Guardians, and Staff:

This letter informs you that five (5) individuals in the Haddonfield School District have tested positive for COVID-19. All contact tracing, if any, has been completed.

We continue to ask parents to keep their students home at the first signs of [COVID symptoms](#). Also, please notify your school nurse as soon as you receive a COVID+ test, which helps the school district respond in the most efficient manner possible.

We have also received several questions about vaccination status among the positive cases reported. While we do not report vaccination status by individual case, 88% of student COVID+ cases this school year have been among unvaccinated students, the majority of which were not vaccine eligible at the time of illness.

Case #58: Central

- The individual is a juvenile male (under 10).
- Symptomatic, tested and received results on Wednesday, November 10.
- The “look back” date is Monday, November 8.
- Last day in school was Wednesday, October 10.

- Based on currently available information, it is unclear whether this individual contracted the virus in school.

Case #59: Tatem

- The individual is a juvenile female (under 10).
- Symptomatic in the evening on Wednesday, November 10, tested, and results on Thursday, November 11.
- The “look back” date is Monday, November 8, and the last day in school was Wednesday, November 10.
- Based on currently available information, it is unlikely that this individual contracted the virus in school.

Case #60: Tatem

- The individual is a juvenile male (under 10).
- Symptomatic, tested, and received results on Thursday, November 11.
- The “look back” date is Tuesday, November 9, and the last day in school was Wednesday, November 10.
- Based on currently available information, it is unlikely that this individual contracted the virus in school.

Case #61: Central

- The individual is a juvenile male (under 10).
- Asymptomatic, tested on Wednesday, November 10, and received results on Friday, November 12.
- The “look back” date is Monday, November 8.
- Last day in school was Friday, October 29.
- Based on currently available information, it is unlikely that this individual contracted the virus in school.

Case #62: Central

- The individual is a juvenile male (under 10).
- Asymptomatic, tested on Wednesday, November 10, and received results on Friday, November 12.
- The “look back” date is Monday, November 8.
- Last day in school was Monday, November 8.
- Based on currently available information, it is unlikely that this individual contracted the virus in school.
